The presence of primary entrapment protection is required for all modes and features beyond basic C2 constant-pressure-to-close performance. LiftMaster® Monitored Entrapment Protection devices, CPS-U, CPS-UN4 and CPS-EI, are designed to work in conjunction with LiftMaster® commercial door operators to provide enhanced door safety and a broad range of modes and features to end users. Monitored photo-sensors or monitored 4-wire sensing edge protection may be selected and must be recognized by the LiftMaster® Logic 4.0 or Medium-Duty Logic circuit board in order to unlock full operator functionality.

Direct Connect to Logic 4.0 and Medium-Duty Logic Operators

Commercial and Industrial Photo-Eyes:

- Direct connect to all Logic 4.0 and Medium-Duty Logic commercial door operators.
- Continuous self-monitoring system satisfies regulatory requirements and permits the use of features and wiring types other than C2, constant-pressure-to-close.
- Additional CPS-U and CPS-UN4 may be added to Logic 4.0 operators, using the CPS3CARD, for increased safety
- Easy alignment! LEDs on each photo-sensor glow steadily when properly connected and aligned; the LEDs will flicker rapidly to indicate an obstruction or misalignment

Retro-Reflective System

Retro-Reflective Commercial Protector System®

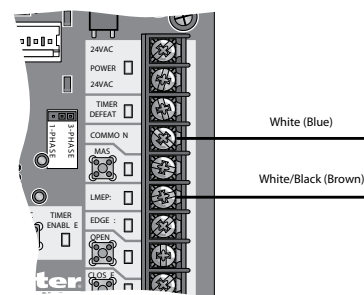
- Utilizes a sending/receiving retro-reflective photo-eye and a specially designed polarized reflector that increases obstruction detection reliability
- Polarized photo-eye design for a safer retro-reflective photo-eye system
- Designed as a normal open circuit, but not a self-monitoring system (does not incorporate industrial code technology)
- Range up to 30 ft. – Indoor use



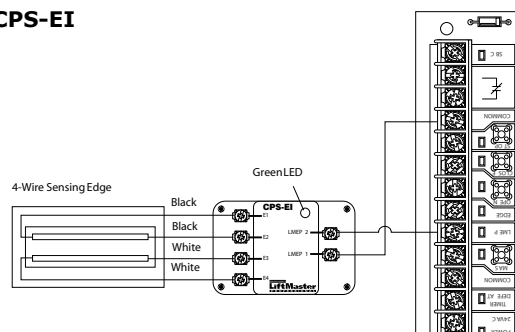
CPS-U, CPS-UN4 and CPS-EI Wiring Connections
